Across the years and till the end, Fred Baron remained true to the vision he had at the dawn of his extraordinary and too-short career as one of the country's preeminent advocates for justice.

A pioneer in asbestos litigation, Fred was spectacularly successful, fighting tirelessly for consumers, workers and others exposed to potentially lethal materials and substances like asbestos, pesticides and lead. Not only did he achieve justice for hundreds of thousands of people against well-heeled corporate defendants, but his leadership in toxic torts helped establish Baron & Budd of Dallas, Texas, as one of the largest and most successful plaintiffs' firms in the U.S. Ultimately, the firm built an international clientele, representing victims throughout the world injured and killed by a poisonous assortment of contaminants.

As a former President of the Public Justice Foundation (then the Trial Lawyers for Public Justice Foundation), Fred inspired lawyers and others to join the organization and carry out Public Justice's mission — to preserve access to America's courts and hold government and corporations accountable for their wrongdoing. He became President of the American Association for Justice (then the Association of Trial Lawyers for America), helped energize the Democratic Party and build the American Constitution Society, and never stopped litigating cases. With optimism and joy, he said, "I am the luckiest human being on the face of the earth. I get to do exactly what I want to do — help people and fight for justice."

When Fred succumbed to cancer on October 30, 2008, people and advocates nationwide mourned the loss of this dynamic and passionate champion of ordinary people facing formidable adversaries. His passing left a huge void, but his exceptional record of leadership and accomplishments advancing the public interest remain as a guidepost for the trial bar and for future generations of lawyers and citizen activists.

The Public Justice Foundation family is grateful to have been in Fred's orbit and to have been privy to his brilliant and creative mind, his buoyant enthusiasm and friendship, and his abiding, immutable commitment to justice.
